This Agreement records the intention of the parties listed above to provide Senior Fitness Class program passes for the "Older Persons" of Alpena County.

ROLE AND RESPONSIBILITIES OF THE PARTIES HEREIN

The Alpena County Board of Commissioners will provide allocations for the fiscal year 2022 not to exceed Twenty Six Thousand, Six Hundred Twenty Eight dollars and no cents (\$26,628.00). Funds will be distributed monthly over a one year period upon submission of proper documentation which is an itemized invoice required for payment of Senior Citizen use of the pool.
