NEW BUSINESS:

- 1) Sparks Grant Update: Bids for the trail improvements and ADA compliant campsite etc., playground equipment and exercise equipment were opened on March 24. Motion by Osbourne with support by Lefebvre to recommend to the full parks board acceptance of the following bids:
 - a) Trail improvements and ADA compliant campsite, etc.
MacArthur Const. - \$129,000
 - b) Playground equipment – two units including installation and safety surfacing
Sinclair Recreation - \$111,200
 - c) Exercise equipment – one unit including installation and safety surfacing
Midwest Recreational Products - \$36,623.50Motion passed unanimously.
- 2) House and garage/workshop electrical improvements – Invitations were sent to 8 local electrical contractors for proposals. The proposals are due by April 1.
- 3) Issues with 2 electrical stations in the campground – The managers will check with electrical contractors and get the cost for inspection and repairs.
- 4) General discussion relative to the replacement of a toilet, need for a new chainsaw, need for documentation of tree removals in the park due to safety issues or improvements, internet service and telephones in the park and possible improvements along the lakeshore.

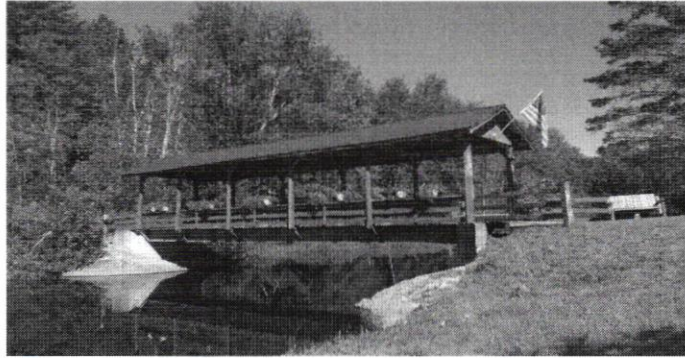
OPEN TO THE FLOOR: General discussion by guests, committee members and managers.
