This list shall be conspicuously posted in each place in which persons in custody of the law are detained, and one or more copies shall be kept in hand. When any person who is detained requests any person in charge thereof to furnish the name of a bondsman, or to put him in communication with a bondsman, the list shall be furnished to the person so requesting, without recommendation, and the person in charge of the place of detention within a reasonable time shall put the person detained in communication with the bondsman.
